**WHEREAS**, the Board of Police Commissioners of Kansas City, Missouri (Board) and the Kansas City, Missouri Police Department (KCPD) from time to time receive donations from individuals, groups and organizations that are interested in assisting KCPD in the ongoing effort to provide police services to Kansas City, Missouri, and

**WHEREAS**, historically all donations that exceed One Thousand Dollars (\$1,000.00) in value are required to be approved by Board, and

**WHEREAS**, Board believes that the Chief of Police of the Kansas City, Missouri Police Department (Chief) should be able to accept donations that do not exceed One Hundred Thousand Dollars (\$100,000.00) in value without specific approval of Board.

**NOW THEREFORE, BE IT RESOLVED** that Board authorizes Chief to accept donations of monies and other items of personal property from individuals, groups or organizations that make such contributions to further the goals of KCPD subject to the following conditions:

- A. No such donation shall inure to the benefit of any individual member of KCPD.
- B. No such donation shall be accepted from any individual, group or organization that has as its primary goal or objective a goal or objective that is inconsistent with the statutory requirements, mission statements and goals and objectives of KCPD.
- C. All donations accepted by Chief will be reported to Board on a monthly basis as an informational item.
